



BBQ and Blues in the Park

TERMS OF ARTIST/ARTISAN PARTICIPATION



ENTRY APPLICATION PROCEDURE:

- ◆ “BBQ and Blues in the Park” Festival Cook Off will be held in the parking area on the corner of Park & Commerce in Mount Holly, NJ. All vendors agree through their participation in this agreement and application, to have their booth space in full display and operational during all hours designated for the BBQ and Blues in the Park Festival. The hours of operation are as follows: **Saturday, July 30th, 2011 -11 AM - 6 PM. Set up time begins at 7 AM.**
 - ◆ To be a vendor, you must complete this application and forward it with your check or money order made payable to “**Main Street Mount Holly**”, and mail to **BBQ & Blues c/o Main Street Mount Holly, 29 Hillside Rd., Mount Holly, NJ 08060**
 - ◆ Application **deadline is July 20, 2011**
 - ◆ The booth fee to be included with your application is:
 - 10' x 10' open space (exhibitor provides tent): \$100.00**
 - 10' x 10' open space, (NON-PROFIT): \$75.00**
 - (Each additional linear foot): \$10.00**
- Free standing, self-contained displays (i.e. kiosks, tents and trailers) are subject to prior approval by the festival management. Due to space limitations, all artists requesting open space locations may not receive such space. Free standing assignments will be granted on a first come, first served basis.
- ◆ Exhibit space includes show security, exhibitor credentials, free parking.
 - ◆ All exhibit spaces are 10' x 10' located in a Township parking lot. Each space will include an additional 2 feet to accommodate tent poles, pegs, etc. Exhibitors requesting open tent space are responsible for providing their own tent or canopy to protect their exhibit space from the weather. These structures must be in good condition without any tears, holes, or faded colors. They must be secured firmly to the ground in the event of wind and/or rain.
 - ◆ Participants must provide their own display equipment. This includes tables, chairs, signage, etc.
 - ◆ Each exhibitor must obtain and provide a **Tax ID #**. If you are a non-profit organization, you **MUST INCLUDE A COPY OF YOUR 501C-3 form** with this application.
 - ◆ Mount Holly Township nor MSMH shall not be liable or responsible for any claims or causes of action arising from the acts of volunteers, employees and members of the Lessee for any claim arising from damage to the person or property of the Lessee, or persons attending the BBQ and Blues in the Park Festival, by reason of the use thereof, by the Lessee.

Mount Holly Township nor MSMH shall not be liable or responsible for any damage to the property of the Lessee, or to any person bringing property onto the event site, caused by water, rain, gas or electricity, which may leak onto the event site or issue from pipes or plumbing or wires or from any employee, facility, or equipment at the event site.

Should the vendor's equipment or supplies be destroyed or damaged by fire, or by the elements, mob, riot, war or civil commotion, or any part of the vendor's equipment or supplies be impractical for use, by any cause, the Township, may, at its discretion, terminate and void this agreement, in which event, the Township shall return to the Lessee, any deposit or payment made in accordance with the terms of this agreement, and the Lessee expressly waives any claim for damage or compensation, should this agreement be so terminated. Neither Mount Holly Township nor MSMH shall be responsible for the theft, loss or damage to Lessee's property or property belonging to anyone with whom the Lessee may have contractual relations, as to the use or part use of the event site.

- ◆ Exhibitors may only display and sell those items approved and specified in this application.
- ◆ Exhibitors may not transfer, let, sublet, share, or sell their contracted booth space.
- ◆ The water supply is limited. Drinking water and any large amounts of water required should be brought to the site for the duration of the festival.
- ◆ Exhibitors **MAY NOT** begin breakdown of their merchandise or booths until the close of the event.
- ◆ **EVERY APPLICANT MUST SIGN AND RETURN THE ENCLOSED BAR-B-QUE FESTIVAL AGREEMENT, ALONG WITH YOUR CHECK, TO BE CONSIDERED FOR PARTICIPATION IN THE EVENT.**
